

PIMCO Low Duration Income Fund

PERFORMANCE SUMMARY

The PIMCO Low Duration Income Fund returned -0.59% after fees in April versus the Bloomberg U.S. Aggregate 1-3 Years Index, which returned -0.34% for the month. Year-to-date the Fund has returned 1.51% after fees, while the benchmark returned 0.11%.

The Low Duration Income Fund continued to provide investors with consistent and competitive monthly distributions through April. The portfolio's duration strategies detracted from performance in April, specifically, the fund's exposure to US duration as rates broadly rose in this market. Meanwhile, the fund's holdings of corporate credit contributed to performance. The performance of residential mortgages was mixed, as non-Agency MBS contributed while Agency MBS detracted from performance during the month.

PORTFOLIO POSITIONING

The fund can be divided into two broad segments: higher yielding assets, which are expected to benefit when economic growth is robust and higher quality assets, which are expected to perform well in risk-off scenarios.

Within the higher quality segment, net portfolio duration was increased over the month as yields rose across the U.S. yield curve. We maintain a preference for US duration, as nominal rates remain higher relative to other developed countries. Within investment grade corporate credit, we continue to favor systemically important banks given fundamentals and defensive sectors, such as utilities and healthcare.

To balance these positions, we maintained our short position to Japanese duration as an advantageous duration hedge.

In the higher yielding segment, we seek to stay diversified across corporate, securitized, and emerging market credit. Within high yield credit, we remain selective and mindful of liquidity conditions favoring senior secured bonds. In securitized credit, we continue to look for opportunities to add senior exposure to asset-backed securities.

MONTH IN REVIEW

Amidst heightened geopolitical tensions, financial markets broadly declined, while bond indices faced challenges as yields rose. U.S. credit spreads were mixed. Developed sovereign bond yields rose, while the dollar strengthened. In the U.S., the 10-year Treasury rose 48 bps to 4.68% as resilient inflation and stronger-than-expected economic data challenged expectation of rate cuts in 2024. In Germany, the 10-year bund yield rose 29 bps to 2.58%. In the U.K., 10-year Gilt yields rose 41 bps to 4.35%, while 10-year Japanese government bond yields rose 15 bps to 0.88%.

Against this backdrop, performance was negative over the month. Within the higher quality portion of the portfolio, the fund's exposure to US duration detracted from performance as rates rose in this market. The fund's exposure to Agency MBS also detracted from performance, while holdings of investment grade corporate credit modestly contributed.

Within the higher yielding portion of the portfolio, the fund's exposure to non-Agency MBS and high yield corporate credit contributed to performance. Meanwhile, holdings of emerging market local debt detracted from performance.

OUTLOOK AND STRATEGY

Higher savings balances and a slower pass-through of monetary policy in the U.S. relative to other developed markets could, in our view, keep inflation above the Fed's 2% target over the cyclical horizon. The lack of progress on inflation in the first quarter could delay rate cuts until later this year or even into 2025, with the Fed's subsequent rate-cutting path also potentially being more gradual than other DM central banks. Additionally, we believe that an economic soft landing is achievable, but both recessionary and inflationary risks remain elevated in the aftermath of unprecedented global shocks to supply and demand.

Within the Low Duration Income Strategy, we remain focused on quality, diversification, and seniority in the capital structure. The strategy has an income-oriented approach that aims to be flexible and resilient in times of market volatility over the longer term.

Effective duration is a measure of a portfolio's price sensitivity to interest rate changes, including expected changes in cash flows caused by embedded options. The **Sharpe Ratio** measures the risk-adjusted performance. The risk-free rate is subtracted from the rate of return for a portfolio and the result is divided by the standard deviation of the risk-free rate subtracted from the portfolio returns. **Volatility** is measured by the standard deviation, or dispersion of a set of data from its mean, based on historical portfolio returns. A larger spread of data indicates higher standard deviation and higher volatility. **Effective maturity** is a weighted average of all the maturities of the bonds in a portfolio, computed by weighting each bond's effective maturity by the market value of the security.
